Agreements between the end user - the customer - and DextraData are in the following order, with the respective higher-ranking document having priority:

- Individual amendments and/or supplements to the contractual agreements;
- Individual-contractual agreements, in particular DextraData's offer;
- End user license terms for the use of DextraData Software, ie these License Terms;
- GTC of DextraData in the basic module, as well as the service module of the General Terms and Conditions corresponding to the subject matter of the agreement;
- System requirements defined by DextraData;
- Standards/DIN norms;
- Legal requirements.
- (2) The use of third-party software for the operation of DextraData software is subject to the license and usage conditions of the respective manufacturers.
- (3) Supplements to "VÜ BITKOM: Terms and Conditions for the Use of Standard Software (Version 3.0)".
 - (3a) to GTC VÜ 1.1: The program description consists of the operating instructions and the installation description, which in turn are divided into "Deployment Guide" and "Prerequisits Guide", which are applied in the respective current or end user-specific version.
 - (3b) to GTC VÜ 1.3: The installation and commissioning of DextraData software is carried out by DextraData together with the end user, unless otherwise agreed. The scope of the installation results from the installation description (cf. 1a). Regulations regarding remuneration remain unaffected.
 - (3c) to GTC VÜ 2.1: The scope of use is composed of the use described and intended in the user manual within the intended environment of use, which is derived from the installation description (cf. 3a), as well as the type of license acquired and its scope.
 - (3d) to GTC VÜ 3.1: Qualified personnel shall be provided by the end user in order to be able to fulfill the requirements from the installation description (cf. 3a) in the end user's environment.
